*November 16, 2018* – Released the reportable and infectious diseases data for 2017 for central nervous system diseases and bacteremias; enteric, food and waterborne diseases; environmental conditions, vector borne and zoonotic diseases, and other reportable diseases and conditions. Released several profile reports that contain this updated data.

*November 14, 2018* – Released the following data from the Department of Education: K-12 Absent 21+ Days, Elementary School Students Not Promoted, Middle School Students Not Promoted, Percent of Children K-12 who are Emotionally Handicapped, Out of School Suspensions K-12. Released School Aged Child and Adolescent Profile report with this newer data.

*November 1, 2018* – Released historical data from 1969 - 2005 for most of the sexually transmitted disease measures.

*November 1, 2018* – Updated – Removed 2017 hospitalization and emergency department data as advised by the Agency for Health Care Administration. This impacted several profile reports and several health indicators.

*November 1, 2018* – Updated- Removed reportable and infectious data prior to 1992 which did not follow current case definitions as advised by the Florida Department of Health, Bureau of Epidemiology. This impacted several health indicators.

*October 31, 2018* – Added new indicators to Health Equity Profile such as: income inequality, food insecurity and severe housing problems.

*October 31, 2018* – Updated life expectancy estimates in Population Atlas and added confidence intervals for these estimates.

*September 24, 2018* – Released 2015 data for the Non-fatal Injury Hospitalizations and Non-fatal Injury Emergency Department Visits profile reports.

*September 21, 2018* – Added a new feature to the Health Equity Profile allowing users to choose a race/ethnicity for comparisons.

*August 30, 2018* – Added the Health Equity Profile with data for 2010-2017.

*August 28, 2018* – Released 2016-2017 data for hospitalizations for non-fatal injuries and emergency department visits for non-fatal injuries.

*August 23, 2018* – Released counts of physicians, nurses, mental/behavioral health care providers for 2018. Released county health department FTE and expenditures data for fiscal year 2017-18.

*August 15, 2018* – Added an analytic report: *Adequacy of Prenatal Care Utilization Index and Adverse Birth Outcomes, Florida 2016*.

*August 6, 2018* – Updated the Population Atlas with data tables to accompany graphs and charts.

*August 6, 2018* – Released the Birth Defects Profile with data for 2011-2015.

*August 1, 2018* – Released a new statistical brief, Components of Population Change, 2017.

*July 18, 2018* – Released data for 2017 for chronic disease-related hospitalizations and emergency room visits, HIV-AIDS case data, and communities using optimally fluoridated water. Profile reports that contain these indicators were also released.

*June 27, 2018* – Released sexually transmitted disease (STD) data for 2017 (Bacterial STDs, chlamydia, early syphilis, gonorrhea, and infectious syphilis).

*June 21, 2018* – Released *Mortality Atlas* and *Birth Atlas* with data and narrative for 2017.

*June 18, 2018* – The Healthy weight profile includes a new section called behavioral health and body image with BRFSS questions. The state and county reports are consolidated to assure consistency and streamline production of the two reports.

*June 18, 2018*– The Pregnancy and Young Child, School Aged Child & Adolescent, and County Health profile reports were updated with 2017 data from Department of Children and Families (foster care, child abuse, child sexual violence) and FDLE crime data as applicable.

*June 18, 2018* – Updated 2017 data from Florida Department of Children and Families: Children in foster care by age groups, child sexual violence, child abuse.

*June 11, 2018* – Updated 2017 data from Florida Department of Law Enforcement: Murder, Rape, Robbery, Aggravated Assault, Burglary, Larceny, Motor Vehicle Theft, Index Crime, Domestic Violence Offenses, Forcible Sex Offenses.

*June 7, 2018* – Released 2017 vital statistics birth, death, fetal death, marriage, and dissolution of marriage data. Individual indicators, profile reports, and query systems with this data were also updated.

*June 1, 2018* – Released an enhanced Population Atlas, providing county-specific tables, charts, and graphs.

*May 28, 2018* – Released estimated population for 2017 for ages less than 1 and 1 to 4. (The estimated population for 2017 for all other age groups was released December 6, 2017.)

*May 21, 2018* – Updated the ICD-10 definition and data for hospitalizations from coronary heart disease. This indicator included only ICD-10 code I-25, primary diagnosis and was changed to ICD-10 codes I-20 - I-25, primary diagnosis. The change effected data for 2015 and 2016.

*May 21, 2018* – Added five new hospitalization indicators with data beginning in 1992. The indicators are: total hospitalizations, hospitalizations for mental disorders, hospitalizations for mood and depressive disorders, hospitalizations for schizophrenic disorders, and hospitalizations for all mental disorders excluding drug and alcohol-induced mental disorders.

*May 15, 2018* – Added high school graduation rates for black, white, Hispanic populations from 2012-2017. (Non-Hispanic data is not available).

*May 9, 2018* – Updated cancer incidence data for 2015 for over 40 types of cancer. Updated profile reports that contain cancer incidence data.

*May 2, 2018* – Updated TB data for 2017 for total cases and cases less than age 15. Updated TB completing therapy for 2015.

*April 24, 2018* – Updated immunization data for 2 year olds (2017), 7<sup>th</sup> grade (2017-18 school year) and Kindergarten (2017-18 school year).

*April 24, 2018* – Updated data descriptions for maternal and child health-related indicators.

*April 23, 2018* – Updated profile reports with the April 10 data changes: County Health, County Health Status Summary, County-State, School-Aged Child & Adolescent, Pregnancy & Young Child, and Healthiest Weight Profiles.

*April 10, 2018* – Added a new Non-Fatal Injury Emergency Department Visits Profile report that provides information by intent and mechanism by age groups.

*April 10, 2018* – Added a new birth indicator which is correlated with infant death: Preterm with Low Birth Weight.

*April 10, 2018* – Updated some birth data percent calculations so that only those with known values are included in the denominator rather than all births. This applied to the percent of mothers with no prenatal care, the percent who began prenatal care in the 1<sup>st</sup>, 2<sup>nd</sup>, or 3<sup>rd</sup> trimester, the percent of mothers with healthy pre-pregnancy weight, and the percent of mothers with high school education.

*April 4, 2018* – Updated the Social and Behavioral Health domain of CHARTS to include behavioral risks from survey data for youth and adults, behavioral health care providers and inpatient bed availability.

*March 26, 2018* – Released five new drug poisoning death measures in CHARTS' four-panel viewer: drug poisoning deaths, drug poisoning deaths of undetermined intent, homicides by drug poisoning, suicides by drug poisoning, unintentional injury deaths by drug poisoning.

*March 23, 2018* – Released *persons living with HIV* measure to CHARTS.

*March 16, 2018* – Updated emergency room indicators on the following profiles: Black Minority Health, Hispanic Minority Health, and Oral Health.

*March 16, 2018* – Updated emergency room indicators (2005-2016).

*March 7, 2018* – Added 8 social determinants of health to the census tract Community Map.

*March 6, 2018* – Updated hospital bed availability and failed environmental facility inspections for 2017.

*March 5, 2018* – Added Non-Fatal Injury Hospitalizations profile with data through 2014 to County Profiles section.

*March 5, 2018* – Added “CHARTS Log in” webinar recording with an accompanying PowerPoint presentation in CHARTS Tutorials section.

*March 1, 2018* - Added CHARTS user accounts to automatically view data for a specified county and receive email about CHARTS updates.

*December 28, 2017* – Released 2016 county and state data to the Behavioral Risk Factor Data Health Indicators. The following profile reports were updated with these data: Oral Health Profile and Pregnancy and Young Child Profile.

*December 28, 2017* – Updated 2002 data from Behavioral Risk Factor Surveillance System.

*December 27, 2017* – Added Update List with information about updates since November 6, 2017.

*November 7, 2017* – Updated Hispanic female population and non-Hispanic female population from 2004 through 2009. Hispanic and non-Hispanic cancer incidence rates were aligned to the revised population.

*November 7, 2017* – Updated cancer death and cancer incidence rates due to revised population data for 2011-2016.

*November 6, 2017* – Updated Preventable Hospitalizations from Iron Deficiency Anemia Ages 1-5 denominator to align with the age group.

*November 6, 2017* – Updated 2011-2016 rates using population as the denominator due to revised population data for these years. This updated many health indicators, Birth Rates Query System, Death Rates Query System, Marriage Rates Query System, and Marriage Dissolution Rates Query System.

*November 6, 2017* – Updated population estimates 2011-2021 in the Population Estimates Query System. Mid-Course Revision of Population Data on FLHealthCHARTS.com: Population data for 2011–2021 and associated rates were updated on Florida CHARTS on November 6, 2017. It is customary to periodically revise population estimates based on new information, such as a census or new mid-course census estimates for prior years. Revising these estimates ensures accurate accounting of the racial, ethnic and gender distribution of the population.
